



Articulating the Goals of the SWATeam

Purpose: In performing Internal Review of HCA GME programs, we:

- prepare them for upcoming ACGME site visits
- provide documentation review
- share successful practices/policies/approaches across the enterprise
- Participate in (or conduct if requested) Special Reviews

Protocol: Collection and review of documentation, followed by Webex (Zoom) meetings with institutional/program leadership, residents/fellows and faculty

- Specialty-specific FAQs and Milestones
- Most recent ACGME Letter of Notification and progress on Citations
- ACGME Surveys

Now we have a small employed Accreditation Team that works with new programs applying for accreditation and site visit preparation, among all other things ACGME!

- Started working together May 13, 2020
- (19 pre-pandemic site visits in 2020)
- So far, 168 programs and institutions with virtual site visits
- 29 in 2020, 86 in 2021, 53 so far in 2022 (scheduled through 6/16)



Scheduling the sessions: when?

 Upon notification of a site visit, I prepare a calendar and email to the program/institution. Many site visit notifications are very close to 30 days' notice.

In preparation for your Wednesday November 3 Site Visit, I wanted to recap some important dates and documents! Please feel free to forward part or all of this email as appropriate.

The ACGME has established Wednesday October 20 as the documentation upload deadline. In order to review this documentation with you and give you enough time to make the recommended edits before Wednesday October 20, we propose Wednesday October 13 @ 5pm EDT for 1 hour for the SWATeam meeting with you.

In order to give the SWATeam enough time to carefully review your documentation, we would recommend Wednesday October 6 as the date that you upload your updated documents to webADS so that I can distribute to our SWATeam.

***We also ask that you review the dates/times available for our SWATeam to meet with your faculty for a prep session and your residents for a prep session during the week of October 25, 2021. Please see the calendar below to SELECT ONE DATE/TIME for each of these prep sessions!

Please confirm ASAP for <mark>Wednesday October 13 @ 5pm EDT for 1 hour</mark> and for TWO sessions during the week of October 25, 2021.***



Documentation to update includes:

- webADS (common program information) needs to be up to date for August/September 2021 (last updated August 2020)
- Specialty Specific Application (last updated May 2018) You will have to complete a new Orthopaedic Surgery Specialty Specific Application (September 2020), which I've attached. Some information will be able to be copied from your 2018 app, and then updated to present tense, compliant with requirements and accurate for your program in 2021.
- Block Diagram (ensure up to date for this academic year last updated August 2020)
- And all attachments (see below last uploaded 2017, 2018 or not at all)

The SWATeam needs time to do a thorough review of the first list of documents in order to have a productive meeting with you on Wednesday October 13 @ 5pm EDT for 1 hour. You will then have 7 days to incorporate suggested edits before the Wednesday October 20 deadline.

- SWATeam members relate their (remote) site visit experiences and pose typical SV questions. Review SV profile (and Exec Summary with faculty)
- **AFTERWARDS**, I provide a Faculty Executive Summary document: contains requirements PLUS program-specific information added by PD and PC.

Faculty Development

Faculty members must:

- be role models of professionalism;
- demonstrate commitment to the delivery of safe, quality, cost-effective, patient-centered care;
- demonstrate a strong interest in the education of residents;
- devote sufficient time to the educational program to fulfill their supervisory and teaching responsibilities;
- administer and maintain an educational environment
- conducive to educating residents;
- regularly participate in organized clinical discussions,
- rounds, journal clubs, and conferences; and,
- pursue <u>faculty development</u> designed to enhance their skills at least annually in:
 - Education (Feedback, Supervision, Teaching, Evaluation and Mentorship)
 - Quality Improvement
 - Well-Being
 - Patient Safety

Common themes and observations Positive


- Full, well-rounded review of citations, PLAs, block schedule, participating sites, faculty roster, institutional documentation, etc.
- Our team relates what a virtual site visit entails, including questions asked
- Ability to make them more aware of our HCA GME resources
- The more we scrutinize, advise and fix practices and documentation the more citations we avoid and the better quality programs we have
- Division to division/program to program "best practices" shared and included – in addition to "what to expect" from the site visit

Lessons Learned

- Initial application language not updated at all.
- Program attention to detail sometimes lacking or deemed unimportant
- Some programs are initially defensive
- Early reviews (absent impending site visits) had little impact
- ALWAYS review Versions 2, 3, etc.
